## IT IS ORDERED THAT:

- 1) the Appeal be dismissed;
- 2) ARL's costs of the Appeal be paid by AMG, such costs to be assessed on

the standard basis if not agreed;

- 3) AMG do pay the sum of £115,000 to ARL pursuant to CPR 44.3(8) as payment on account of ARL's costs of its Part 20 Claim (including ARL's costs of the Appeal) by no later than 4 pm on Friday, 28<sup>th</sup> November 2008;
- 4) ARL be released from the cross-undertaking in damages it gave pursuant to paragraph 3 of the order of John Randall QC dated 18<sup>th</sup> November 2005 (the "Cross-Undertaking"); and
- 5) The sum of £50,000 paid by ARL into the client account of its solicitors, Magwells, pursuant to paragraph 2.1 of the order of Evans-Lombe J dated 2 March 2006 in order to fortify and secure the Cross-Undertaking, together with any interest on such sum be released to ARL forthwith.
